Residential and Local Road Projects



Summary of Projects

Hamlin Road - It will be widened to three lanes (adding a center turn lane) between Livernois and Rochester with intersection improvements at Rochester Road, and re-paved between Rochester and Dequindre. No full closures have been announced but there will likely be significant slowdowns.

Rochester Road - Re-paving between M-59 and **Tienken Road** except for downtown Rochester (mostly nights and weekends)

Tienken Road - Closed from March thru September between Livernois and Rochester to complete the reconstruction and widening project. Closed from June through November between Livernois and Adams for major re-paving.

Cumberland Woods - More slab replacement will be done on Lake Ridge. Other areas through the sub will be patched.

Landscaping

The HOA would like to remind our residents to please edge your lawns occasional during the summer months. Lack of edging promotes grass and weed growth in the sidewalks and makes for poor curb appeal. This request applies to those who <u>rent</u> as well.

Property Values

Property values have increased over 10% both in the city and in the subdivision over the past year. This is a sign that we live in a great city and a great neighborhood.

Traffic Concerns

A new 18-home subdivision named Cumberland Pointe will be built to the North of our location with a new entrance onto Livernois from Kentucky. The new subdivision will connect to Cumberland Hills alleviating traffic flow into our neighborhood.

Trash Pick Up

The HOA has received concerns from our residents that some homeowners are placing trash receptacles and other large items out more that 24 hours before scheduled pickup and leave them for more than one day before they are stored away. Our bylaws state that you cannot place these items out more than 24 hours prior. For our new residents please note that trash pick-up is delayed one day during a week where a National Holiday falls prior to Wednesday.

Based upon the great feedback regarding the 2014 Block Party the HOA is pleased to announce that we are in the planning stages for 2015. Treasurers Report

Dues notices will be mailed at the end of April for payment by June 1. The dues will remain the same this year, \$175.

As we did last year, we will be strict on the timely collection of dues. Untimely payment results in an undue strain on the resources of the Board and the costs of the association - additional mailings, lien filings, and small claims court filings cost each homeowner money.

A lien has been filed for nonpayment of dues for 1 homeowner. One homeowner is currently less than one-year past due and is honoring their requested payment plan.
